I. Background

Matawa First Nations Education

Matawa First Nations is a Tribal Council of nine Northern Ontario First Nations located in Nishnawbe Aski Nation (NAN). The Matawa First Nations Education Authority (MFNEA) provides quality, accessible, community based educational support services for eight Matawa First Nation schools. In addition, the MFNEA provides post-secondary support services and operates the Matawa Learning Centre. Regional Education Strategic Plan

In July 2015, the Matawa Chiefs in Assembly approved by resolution the renewed *Regional Education Strategic Plan*. The strategic plan includes ten strategic initiatives, each of which has associated short-, medium- and long-term goals. The ten strategic initiatives are:

1. A Matawa First Nation Curriculum and Incorporation of First Nation Culture and History
2. Special Education
3. Student and Parental Supports
4. Minimum Standards and Reporting
5. Student Attendance, Retention and Completion
6. Teacher Recruitment and Retention
7. School Infrastructure
8. Information Technology
9. Post-Secondary School Readiness and Retention
10. Partnerships



The Chiefs resolution also called for the development of strategic and business plans for the MFNEA, which will inform the role that the MFNEA will take in the implementation of the strategic initiatives and what organizational structure will best facilitate this work.

II. Scope of Work

Matawa First Nations Education Authority Curriculum Development Process

The MFNEA is seeking to establish a process for curriculum development to meet goals identified in the renewed *Regional Education Strategic Plan*. In order to achieve this, a Curriculum Development Committee (CDC) will create the process needed for the development of regional curriculum for Matawa First Nations schools, including related policies and procedures and a Terms of Reference for the committee.

To this end, the MFNEA is requesting proposals from qualified consultants, or firms with a demonstrated ability to provide professional services, for the facilitation of the curriculum development process and meetings of the Curriculum Development Committee. Specifically, the qualified consultant or firm will be required to:

- Review the *Regional Education Strategic Plan*;
- Review *Jury Recommendations from First Nations Youth Inquest*, and other available documentation such as Truth and Reconciliation Commission's *Calls to Action*, *The Journey Together: Ontario's Commitment to Reconciliation with Indigenous Peoples*, and operational and policy documents for regional school boards and the Ministry of Education;
- Facilitate a meeting in which participants create the process needed for the development of regional curriculum for Matawa First Nations schools including policies, procedures and Terms of Reference (TOR) for the Curriculum Development Committee; and
- Develop a presentation that will be used to share the policies, procedures and TOR with Matawa communities for their input and feedback.

Deliverables for this contract will include:

- The policies and procedures required for a Curriculum Development Committee to develop regional curriculum; and
- A Terms of Reference for the Curriculum Development Committee.
