# Matawa Education Department Regional Education Agreement Consultant

## I. Background

#### **Matawa First Nations Education**

Matawa First Nations Management is a Tribal Council of nine Northern Ontario First Nations located in Nishnawbe Aski Nation (NAN). The Matawa Education Department (MED) provides quality, accessible, community based educational support services for participating Matawa First Nation schools. In addition, the MED provides post-secondary support services and operates the Matawa Education & Care Centre. #### **Regional Education Strategic Plan**

In July 2015, the Matawa Chiefs in Assembly approved by resolution the renewed *Regional Education Strategic Plan*. The strategic plan includes ten strategic initiatives, each of which has associated short-, medium- and long-term goals. The ten strategic initiatives are:

- 1. A Matawa First Nation Curriculum and Incorporation of First Nation Culture and History
- 2. Special Education
- 3. Student and Parental Supports
- 4. Minimum Standards and Reporting
- 5. Student Attendance, Retention and Completion
- 6. Teacher Recruitment and Retention
- 7. School Infrastructure
- 8. Information Technology
- 9. Post-Secondary School Readiness and Retention
- 10. Partnerships

The Chiefs resolution also called for the development of strategic and business plans for the MED, which will inform the role that the MED will take in the implementation of the strategic initiatives and what organizational structure will best facilitate this work.

#### II. Scope of Work

**Matawa Education Department Regional Education Agreement Consultant** 

Beginning in fiscal year 2019-2020, Indigenous Services Canada (ISC) is implementing a new policy framework for First Nation elementary and secondary education. This new framework is aimed at fundamentally improving the way ISC funds First Nations elementary and secondary education, while supporting regional and local diversity and implementing the principle of First Nations control of First Nations education.

The MED is seeking develop a draft Regional Education Agreement (REA) that responds to the education goals and priorities set by the Matawa First Nations. The REA will identify collaborative education service delivery strategies and outline how the Government of Canada can best support First Nations schools, students, communities, and education organizations in ensuring that First Nations students receive a high quality, linguistically and culturally appropriate education that improves outcomes.

To this end, the MED is requesting proposals from qualified consultants, with demonstrated ability and expertise, to provide an analysis of current education funding within Matawa First Nations and existing REAs within other First Nations or organizations. The analysis will be used to begin the development of a draft REA which will be presented to each of the Matawa First Nations communities.

Pending funding for the 2020-21 fiscal year, the scope of work will continue to a next phase of the REA process for Matawa First Nations, and the consultant selected for this initial phase may be retained to continue the work on the REA for the Matawa First Nations.

Specifically, the qualified consultant or firm will be required to:

- Review and analyze current education funding within Matawa First Nations;
- Review and analyze existing REAs within other First Nations and organizations;
- Support the development of a draft REA that responds to the education goals and priorities set by the Matawa First Nations; and
- Present information regarding ISC's new policy framework and the draft REA to Matawa First Nations communities.

Deliverables for this contract will include:

- A review of current education funding within Matawa First Nations;
- A review of existing REAs within other First Nations and organizations;
- A preliminary draft of an REA; and
- Community engagement facilitation and related presentation materials for sharing information about ISC's new policy framework and the preliminary draft REA within Matawa First Nations.
