## COVID-19 PROTOCOLS FOR ENTERING MATAWA 808 WINTER ROAD NETWORK

---

As of January 22, 2022 a CHECKPOINT will be setup at the Matawa 808 Winter Road entrance north of Pickle Lake. It will be manned 24/7 until the winter road closes.

**All documentation must be sent to the First Nation to receive entry approval. This includes Vaccination certificate with dates and negative COVID results.**

**Any traveler without authorized paperwork at the Checkpoint will not be allowed to enter. Paperwork must also be presented at corresponding First Nation checkpoints.**

Each First Nation has specific entry protocols. At a minimum travelers should meet the following requirements:

- Proof of double vaccination & booster (if eligible) with dates
- Negative PCR/Molecular COVID test results (within 72hours prior to entry)
- Signed approval form from the First Nation

All travelers are encouraged to limit contact with others on the road as much as possible.
