Position: Safe Sobering Site Addiction Crisis Worker 1 Female Full Time / 2 Part Time

Formed in 1988, Matawa First Nations Management (Matawa) is a Tribal Council providing services to nine member communities in Northern Ontario. The organization is dedicated to providing its members with advisory and support services in the areas of communications, economic development, education, finance and business, health, membership and technical services.

The Matawa Education Department supports quality, accessible, communitybased educational services for the eight Matawa First Nations Communities of Aroland, Eabametoong, Nibinamik, Long Lake #58, Ginoogaming, Neskantaga, Marten Falls and Webequie First Nations. In addition to providing advisory services to Education Authorities and Matawa First Nation leadership, the Education Department administers post-secondary support services for five Matawa First Nations; operates the Matawa Education and Care Centre, a private secondary school located in the Thunder Bay; and coordinates the Student Nutrition Program for six communities. The MECC Safe Sobering Site however, will accept youth from all Matawa communities.

Position Summary:

Reporting to the Education Department Manager, the Matawa Education and Care Centre (MECC) Principal, Vice Principal and Safe Sobering Site Coordinator. The Addiction Crisis Worker is responsible for working with the Safe Sobering Site team to provide immediate crisis intervention, support and assistance to students at the MECC and the Safe Sobering Site. Additionally, the Addiction Crisis Worker will help develop care plans for students and will provide support to students in their after-care plans.

The MECC Safe Sobering Space will be available for Matawa students, primarily aged 13-22 years, that need safe and supervised detoxification and stabilization. MECC will be working under the direction of health care providers. As a member of the MECC team, the Addiction Crisis Worker will collaborate with the Safe Sobering Site team to provide support to the students who are





















admitted in the detox center. The Youth Residential Worker will ensure the ordered care plans are followed, will supervise students at the site while they detoxify, and will provide support to students in their after-care plans. The Youth Residential Workers will maintain case notes, tracking of any referrals/specialized services, after-care services, and program reporting requirements.

This position will require the successful applicant to work nights 12:30am-8:30am

This is a contract position to June 28, 2023, with the possibility of extension pending funding and a successful performance review.

Preferred Qualifications/Requirements:

- Bachelor's degree or college diploma in one of the following areas: Community Services (Social Worker, Social Service Worker, Child & Youth Care, Native Child and Family Services, Health Services);
- Minimum three years' related work experience working with youth or students;
- Understanding of addictions, substance abuse and mental health issues;
- Knowledge of First Nation and Ontario education systems;
- Demonstrated ability to work effectively with school staff, parents, administration, government and First Nation organizations;
- Knowledge of local programs and services for youth;
- Exceptional oral and written communication skills;
- Ability to maintain a high level of confidentiality;
- Knowledge of Ojibway, Cree or Oji-Cree is considered an asset. Ability to work effectively with staff,parents and guardians, and administration
- Valid Ontario Driver's Licence
- Current Criminal Records Check and vulnerable records check
- Current TB skin test
