#### Opioid Aftercare Engagement Coordinator - Temporary Full Time

#### OVERVIEW:

Under the supervision of the Health Administrator, the Opioid Aftercare Engagement Coordinator will perform and provide a wide variety of duties and responsibilities in relation to mental health and addictions. **This position will end on March 31, 2024.**

**Competitive wages and travel incentive will be provided to help offset the cost of gas and insurances.**

#### QUALIFICATIONS:

- Social Worker diploma and addiction counselling certificate.
- Minimum 2 years' experience delivering programming, counseling, and case management services to mental health and addiction clients.
- Minimum of 2 years' experience in case management.
- Extensive background in substance misuse, particularly with opioid misuse.
- Working knowledge of First Nation culture, traditions and values and their influence and impact on wellness.
- Understanding of multi-generational abuse, substance misuse and trauma.
- Ability to speak Cree and/or Ojibway an asset.
- Must have a vehicle and a valid driver's license.
- Excellent interpersonal and communication skills with dealing clients.
- Excellent computer skills.
- Must have good organizational skills.
- Ability to operate office equipment.
- Must pass drug and alcohol test.
- Must pass criminal background check.
- Able to use cEMR for programing and input of data.

#### DUTIES AND RESPONSIBILITIES:

- Reach out to those community members seeking intervention in the areas of mental health and addiction.
- Screen and assess clients' state of physical, emotional, mental, and spiritual welling being.
- Work in partnership with other community programs (i.e. CATC, Jane Mattinas Health Centre, and Eagles Earth Healing Centre).
- Plan and implement regular educational programs to the elementary and secondary levels on prevention of opioid and drug use/misuse.
- Plan and implement community/individual sessions regarding drug, alcohol & mental health programs.
- Develop and provide substance abuse information services (literature, workshops etc.)
- Provide mental health support services to members of Constance Lake by working with individuals to create a holistic service plan, focusing on strength, healing, and capacity.
- Provide client referrals to appropriate organisations/agencies available to members of Constance Lake First Nation as required.
- Provide community-based group support services to individuals and families impacted by mental health and addiction issues.
- Coordinate and facilitate access to traditional healing and other cultural programming.
- Network with other mental health and addictions workers and agencies and link clients to them
