### **Position: Indigenous Cultural Reintegration Youth Worker**

#### **Background:**

Formed in 1988, Matawa First Nations Management (Matawa) is a Tribal Council providing services to nine member communities in Northern Ontario. The organization is dedicated to providing its members with advisory and support services in the areas of communications, economic development, education, finance and business, health, membership and technical services.

The Matawa Education Department supports quality, accessible, community-based educational services for eight Matawa First Nations communities of Aroland, Eabametoong, Nibinamik, Long Lake #58, Ginoogaming, Neskantaga, Marten Falls and Webequie First Nations. In addition to providing advisory services to Education Authorities and Matawa First Nation leadership, the Education Department administers post-secondary support services for 5 Matawa First Nations; operates the Matawa Learning Centre, a private secondary school located in Thunder Bay; and coordinates the Student Nutrition Program for 6 communities.

Matawa is inviting applications for the position of **Indigenous Cultural Reintegration Youth Worker** with the Matawa Education Department. The Matawa Education and Care Centre (MECC) located in Thunder Bay, Ontario, provides a unique learning environment to support students as they move toward the successful completion of their secondary education and continue on their pathways to work, training or post-secondary education programs.

#### **Position Summary:**

Reporting to the Matawa Education Executive Director of Education, and the Youth Inquest Manager, the Indigenous Cultural Reintegration Youth Worker (ICRYW) develops, facilitates and/or coordinates a variety of programming for youth relating to cultural revitalization and indigenous mental health promotion and practices. The ICRYW works with youth, families, and applicable staff and external partners, in the prevention, intervention, and immediate care for Matawa youth impacted by gangs, human trafficking, historical trauma, violence and/or other significant issues and situations.
