## SUPPORT FOR MATAWA HEALTH CO-OPERATIVE IN PLANNING WITH CHARTER OF RELATIONSHIP PRINCIPLES

WHEREAS the Matawa Health Co-operative has been mandated by the Matawa Chiefs to further develop health programming and services that include primary care, mental health, physician, nursing, Elder, public health and a variety of other programming area which support personal and community wellness; and

WHEREAS Canada and the Ontario Government have recently signed a Charter of Relationship Principles with Nishnawbe-Aski Nation governing Health Transformation; and

WHEREAS the Matawa First Nations Chief Council in Resolution 03 - 15/12/2016 mandated Matawa Health Co-operative as a member of the Joint Steering Committee to support the Charter of Relationship Principles; and

WHEREAS it is envisioned that the transfer of health programs and services will be addressed in the Charter of Relationship Principles; and

**WHEREAS** social programs and other ministries/departments will be involved in the Health Transformation:

**THEREFORE BE IT RESOLVED** that Canada, Ontario, and Nishnawbe-Aski Nation support Matawa First Nations and the Matawa Health Co-operative to participate in the developmental planning of this Health Transformation; and

**BE IT FURTHER RESOLVED** that Canada, Ontario and NAN support funding to individual Matawa First Nations and the Matawa Health Co-operative on planning, implementation and piloting health options which support individual and community wellbeing, along with capital, human resource training, capacity building, medical records, technology and cultural assessments and supports; and
