# VISION

We will do whatever is necessary in order to protect our land, our water and our resources for the future generations. We agree that we must stand together in order to ensure our nation is protected. Therefore, we assert our Aboriginal and Treaty rights to the land, water and resources by requiring written consent before any development activity may proceed. Failure to consult, accommodate and receive the consent of the First Nation(s) to proceed with any work or activity is an unjustified infringement upon our Aboriginal, Treaty and Custodial rights as First Nations.

# MISSION

- 1. Protection of our land, our water and our resources.
- 2. Protection of our Rights as Peoples of the Land. We have Inherent, Aboriginal Title, Custodial and Treaty Rights.
- 3. We respect and trust the autonomy of each First Nation, respecting each other's priorities and paths to reach our common goals.
- 4. We want to maximize opportunities for our Peoples in any developments that they consent to, such as resource revenue and economic benefits.
- 5. We will achieve our goals through control and ownership of any development and activities in our territories.

# **OVERVIEW:**

The Matawa First Nations Chiefs Council consists of the nine (9) First Nations Chiefs who represent the Matawa First Nations communities and provide overall direction to the organization and broad decision making on collective issues. The mandate of the Chiefs Council office is:

- To provide logistical, technical, policy and political advice to First Nations Chiefs both collectively and individually
- To support managers within Matawa First **Nations Management**
- To liaise with external organizations to support Matawa First Nation members

## MATAWA JURISDICTION COMMITTEE:

Working with Regional Framework Department and Chiefs Council staff, the purpose of this Committee is to provide technical support to the Matawa Chiefs Council in the areas of jurisdiction. The objectives are to:

Analyze, review and recommend collective advice on jurisdiction issues. This includes securing a Statement of Commitment (SoC) with Ontario that will focus on land management, roads and permits. The SoC is being finalized between representatives of Ontario and a working group of: the larger jurisdiction committee (the 4x4).



- Critically assess the negotiations process
- Promote information sharing, best-practices, education and communications to Matawa First Nations Leadership
- Promote indigenous knowledge, history and language among Matawa First/Nations leadership
- Identify gaps, research and gather information for First Nations Leadership

The Jurisdiction Committee has developed their own Terms of Reference, workplan, budget, confidentiality paper and hired technical support.

# CHIEFS COUNCIL OFFICE KEY PRIORITY AREAS:

## Jurisdiction

- The Chiefs have met with the Premier of Ontario, Kathleen Wynne three times (October, January and April) to discuss and prioritize jurisdiction areas.
- Reaffirm the Jurisdiction Committee and its working group to negotiate with Ontario
- Securing a Statement of Commitment from Ontario to work with our First Nations, starting with the following areas as it pertains to jurisdiction - permits, roads and land management
- Regional Framework Activities Re-establish the Regional Framework for active engagement with Ontario on the four pillars: Infrastructure, Environment, Community Wellbeing, Resource Revenue Sharing
- Lobby the federal government and bring them to the negotiations table.
- Support staff within the Regional Framework Agreement (RFA) Secretariat

# Support the Social-Health Needs of Communities

 Establish the Matawa Health Co-operative to support community health programs and services directed by the First Nations.

- Lobby Ministers of Canada and Ontario for immediate community-based programs and health transformation
- Support proposal to Canada and Ontario to better serve Matawa First Nations members in health and social services.

# Promote Education and Training of First Nation Members

- Support Matawa Education Department and the Matawa Learning Centre to establish a student accommodations centre in Thunder Bay
- Support Matawa Education Staff as an active participant in the Coroner's Inquest into Student Deaths in Thunder Bay.
- Work with KKETS staff to promote community training supports in the areas of adult education, apprenticeships, worker associations and need for worker retention with employers.

## **Promote Safe Communities**

- Working with the Crime Prevention Committee in Thunder Bay
- Establish an Indigenous Peoples Court in Thunder Bay and the links to our communities and support services



# Support Infrastructure to First Nations

- Support for First Nation Broadband Working Group and Matawa Broadband Proposal
- Support community based planning, engagement and capacity building on energy initiatives in the areas of transmission, distribution and generation (i.e.: solar)

# **ACCOMPLISHMENTS:**

# **Economic Development**

- Engagement with Katheryn McGarry, Minister of Natural Resources to promote First Nations direction and opportunities in the Ogoki Forest.
- Establishment of the Ogoki Forest Development Corporation which now will manage the Ogoki Forest Sustainable Forest

## Education

- Engagement with all levels of government to support the educational needs of Matawa First Nations students
- Partnerships with the City of Thunder Bay to help create Matawa Student Accommodation Centre
- Securing of mental health services from students at the Matawa Learning Centre.

# Health

- Establishment of Matawa Co-op, the first First Nation Health Co-op in Canada.
- Recognition of Matawa as part of the board health planning for Northern Ontario
- Establishment of the Remote First Nations Physician Residency Program with Eabametoong, the Northern Ontario School of Medicine, and the Ministry of Health and Long Term Care, the first such program in Canada.

## Infrastructure

- Engagement with Navdeep Bains, Minister of Science and Innovation to support Matawa First Nations broadband and telecommunications needs.
- Establishment of RapidLinks, a firm to build and operate broadband to Matawa First Nations
- Capacity development of community members who participate in directing the Broadband initiative
- Support to communities in the area of community wellness, financial preparedness and housing construction

# Jurisdiction

- Met with Premier Kathleen Wynne of Ontario three times to outline First Nations direction on iurisdiction
- Establishment of Chiefs Working Group to negotiate with Ontario on jurisdiction priorities.

# CHALLENGES:

# **Consistent Funding**

- There is a need for enough funding to arrive at the right time so communities and Matawa can start initiatives early in the fiscal year
- Funding need to be long term, not project based or initiatives will falter and staff will be lost



## Communications

- Many issues being asked of communities by government are quite complex – translation and interpretation of material and ideas are required.
- Capacity building and understanding of project management of these issues is major asset required.
- On-going communications to community members of what is happening or not in negotiations and how much information should be confidential.

# Multiple Ministries and Departments

 Co-ordinating between the different Ministries and Departments to achieve a whole of government (or one-window) approach is difficult but necessary.

## **Time Pressures**

- Governments want communities to make fast decisions. However, communities need time, capacity building and resources to assess their traditional territory, service needs, and future plans.
- Elections at the First Nations and Ontario level can create timing challenges.

# **OPPORTUNITIES:**

- Greater First Nation jurisdiction of First Nation traditional territories
- Bringing in the Federal Government into negotiations
- Increased health and social supports to First Nation members
- Increased housing to First Nations
- Increase financial capacity building for First Nations
- Creation of economic structures to support First Nations owned and operated by communities that build collective momentum and First Nation accomplishments

The end date of the agreement is March 31st, 2018. KKETS' is in the process of seeking a renewal of ASAP. The Executive Director and Project Coordinator is in dialogue with the funder in seeking the renewal process. Further information will be provided when readily available.

**THEREFORE BE IT RESOLVED** that the Matawa Chiefs in Assembly recommend the following factors to be included in the allocation model:

- a) Isolation: this should be considered due to the high cost of living and geographical locations of the Indigenous communities north of 50th parallel;
- b) High unemployment rate: the rate of unemployment in the northern communities needs to be a factor in the allocation model which is never considered in labour market studies for the northern communities;
- c) Language: should be considered in the northern Indigenous communities because English is not our first language, consideration needs to be made for language translation;
- d) Service delivery component: for organizations that deliver services to the northern Indigenous communities, a northern factor needs to be added in the calculation for administration and not limiting it to fifteen (15) percent.

# **UPDATE**:

ASETS Program has been extended to March 31 2018. KKETS has developed a northern position paper along with Sioux Lookout Aboriginal Area Management Board to identify factors that affect our remote communities. It was submitted to ESDC to consider including it in the ASETS Allocation Model for the proposed ASETS multi year agreement.

THEREFORE BE IT RESOLVED that the Matawa Chiefs in Assembly support Four Rivers in the submission of proposals to secure funding to support this needed research and the associated discussions; and

FURTHER BE IT RESOLVED that the Matawa Chiefs in Assembly formally task Four Rivers with gathering information to develop potential Long-Term Regional Environmental Monitoring Network models (AKA Guardians Programs) for discussion and consideration by the Matawa member First Nation communities.

# UPDATE:

In October 2016, Four Rivers employees travelled to Ottawa to meet with representatives of First Nations and groups with guardians programs from across the country. This event was coordinated by the National Indigenous Guardians Network. We received information on numerous guardians programs, their funding status, had the opportunity to present, and attended a session to lobby the Minister of the Environment and other MPs at parliament for funding for guardians programs. In the spring of 2017, federal funding was announced to the National Indigenous Guardians network to support quardians programs. This funding is not available to communities or even regional programs yet, however we are continuing to be involved in the network and pursue this option as well as maintain networks with active guardians programs.

To-date our research as yielded limited other funding options specific to dedicated, ongoing environmental monitoring/guardians programs. The Regional Framework Agreement specifically identifies long-term environmental monitoring as a priority/focus area. In the fall of 2016, Four Rivers pursued support from Matawa member First Nations Chiefs to direct this funding towards environmental monitoring programing (Resolution #26). Four Rivers has also actively pursed project funding that will help advance environmental monitoring across the region and involve community based monitors on a project or initiative basis. Four Rivers was successful in securing funds for wolverine research for the winter of 2016, bat research for 2017 and climate change research in 2016 to 2017. We are also pursing opportunities to support monitoring of gaseous mercury through community based monitoring stations.

- information on the federal environmental assessment process was made available on our website and social media;
- surveys were used to collect community feedback while keeping comments anonymous; and,
- Four Rivers attended the Indigenous Participation event held in Winnipeg and presented community feedback
  regarding CEAA because the NEB is responsible for administering CEAA for energy related projects such as the
  Energy East Pipeline. In general, Matawa communities will only engage with the National Energy Board when
  administering CEAA environmental assessment process on energy projects.
- Written submissions were made reflecting the views of the Matawa member communities based on the feedback received during this participant opportunity as well as past events such as the Environmental Assessment Conference.

The reviews have been completed and currently, final project reporting is outstanding.
