We will do whatever is necessary in order to protect our land, our water and our resources for the future generations. We agree that we must stand together in order to ensure our nation is protected. Therefore, we assert our Aboriginal and Treaty rights to the land, water and resources by requiring written consent before any development activity may proceed. Failure to consult, accommodate and receive the consent of the First Nation(s) to proceed with any work or activity is an unjustified infringement upon our Aboriginal, Treaty and Custodial rights as First Nations.

MISSION

- 1. Protection of our land, our water and our resources.
- 2. Protection of our Rights as Peoples of the Land. We have Inherent, Aboriginal Title, Custodial and Treaty Rights.
- 3. We respect and trust the autonomy of each First Nation, respecting each other's priorities and paths to reach our common goals.
- 4. We want to maximize opportunities for our Peoples in any developments that they consent to, such as resource revenue and economic benefits.
- 5. We will achieve our goals through control and ownership of any development and activities in our territories.

 Analyze, review and recommend collective advice on jurisdiction issues. This includes securing a Statement of Commitment (SoC) with Ontario that will focus on land management, roads and permits

- Promote information sharing, best-practices, community engagement and communications to Matawa First Nations Leadership
- Promote Indigenous knowledge, history and language among Matawa First Nations leadership

REGIONAL FRAMEWORK WORKING GROUP (RFWG):

Working with Regional Framework Department, Chiefs Council, Four Rivers and Economic Development staff, the purpose of this RFWG is to provide technical support to the Matawa Chiefs Council and Ontario in the four pillar areas of the regional framework: Environmental Assessment, Infrastructure, Socio-Economic Benefits and Resource Revenue Sharing.

The objectives are to develop options and plans for decision making on the four pillared areas. This will include all the Provincial Ministries and Federal Departments involved in and affected by mineral activities. Various sub-group for each pillar may arise. They will support the negotiations process as per the Regional Framework.

Working with Matawa Chiefs Council and other Health Staff, the MHC is a legal entity which will support improved health access in each Matawa First Nation in a cultural and community appropriate manner. The MHC will:

- Assist communities in their community health plans
- Implement and deliver an Indigenous
 Interprofessional Primary Health Team (i.e.: physicians, nurses, health staff) support to each
 First Nation:
- Provide additional mental health and crisis services to First Nations thought the Primary Health Teams
- Transfer federal nursing services to First Nations for a more integrated approach to health care delivery at the community level
- Work with Northern Ontario School of Medicine to secure additional Residents and full-time physicians to the Matawa First Nations

CHIEFS COUNCIL OFFICE KEY PRIORITY AREAS:

Jurisdiction

- Securing a Statement of Commitment from Ontario to work with our First Nations, starting with the following areas as it pertains to jurisdiction in three initial areas:
 - Permits
 - Roads
 - Land Management
- After community engagements in each First
 Nation and Committee revisions in the fall of
 2017, a revised Statement of Commitments was
 submitted to Ontario in January 2018. However,
 owing to the election in June 2018, further work
 on the Statement of Commitment was delayed.

Regional Framework Activities


- The Regional Framework was restructured with Ontario and proposed joint working groups based on the four pillars:

- Support staff within the Regional Framework Agreement (RFA) Secretariat


Economic Development

 Promoting self-sufficiency, equity ownership and economic development opportunities for First Nations

Promote Social-Health Needs of Communities

- Support the newly established the Matawa Health Co-operative to develop community health programs and services directed by the First Nations.
- Support Matawa specific funding allocations within new funding announcements by Ontario and Canada.
- Lobby Ministers of Canada and Ontario for immediate community-based programs and health transformation
- Support proposal to Canada and Ontario to better serve Matawa First Nations members in health and social services (i.e.: Environmental Health, Long Term Care, etc.)
- Work with First Nations and Nishnawbe-Aski Nation to initiative activities under the health transformation initiative





Promote Education and Training of First Nation Members

- Support Matawa Education Department and the Matawa Learning Centre to establish a student accommodations centre in Thunder Bay
- Support Matawa Education Staff as an active participant in the Coroner's Inquest into Student Deaths in Thunder Bay including supporting the MLC's application for a Safe Sobering Site
- Work with KKETS staff to promote community training supports in the areas of adult education, apprenticeships, worker associations and need for worker retention with employers.

Promote Safe Communities

- Working with the Crime Prevention Committee in Thunder Bay
- Establish an Indigenous Peoples Court in Thunder Bay and the links to our communities and support services
- Work with Thunder Bay and Area Victims Services to establish urban support for human trafficking and anti-violence

Support Infrastructure to First Nations

- Support for First Nations Broadband Working Group and Matawa Broadband proposal
- Support community-based planning, engagement and capacity building on energy initiatives in the areas of transmission, distribution and generation (i.e. solar)

ACCOMPLISHMENTS:

Health

- Establishment of the Remote First Nations
 Physician Residency Program with Eabametoong,
 the Northern Ontario School of Medicine, and the
 Ministry of Health and Long Term Care--the first
 such program in Canada.
- A unique partnership was also created with Eabametoong First Nation, Matawa First Nations and the Northern School of Medicine at Lakehead University. This was to train physicians during their residency in Remote First Nation (two years) and then have them work in communities afterwards as part of the return of service. First Nation members approve the residents to be trained in their communities. Chief Elizabeth Atlookan has taken an active role in this initiative through the signing of a protocol, along with Matawa Chief Executive Officer David Paul Achneepineskum and Roger Stusser, NOSM CEO, and supporting local Indigenous curriculum development.
- The Chiefs also met with Ovide Mercredi who
 is heading up the Nishnawbe-Aski Health
 Transformation Initiative in December 2017, to
 outline how they would like to see the health
 system transformed for their community members.
- Successful approval of Matawa Health Co-operative applications for:
- 1. Indigneous Interprofessional Primary Care Initiative
- 2. Mental Health Wellness Initiative
- 3. Preparatory Initiative for Nurse Transfer to First Nations
- 4. Creation of Mustimuhw Electronic Medical Records for community health records

In July 2018, the Matawa First Nations Chiefs met with Frances Wesley, Matawa Health Co-op Planner and Carmen Blais, Business Plan Developer, to go over the business plan for the Co-op and its Indigenous Inter-Professional Primary Care Team and Mental Wellness Team. They also met with Crystal Davey to learn about the nursing transfer process which will also work through the Co-op





Infrastructure

- Successful federal and provincial application to fund high speed broadband for Matawa First Nation communities
- Support to communities in the area of community wellness, financial preparedness and housing construction

Regional Framework

 Establishment of joint workplan and multi-ministerial process for technical disucssions and options for decision making

Jurisdiction

 Establishment of baseline Statement of Commitments to Ontario of First Nations expectations on jurisdictional priorities based on community feedback

Economic Development

- Support for Tourism Strategy
- Support for developmental work on energy storage and regional energy body
- Establishment of Rapid Lynx, a firm to build and operate broadband to Matawa First Nations
- The Matawa Chiefs in 2017 lobbied both Federal and Provincial representatives to supports the work of Rapid Lynx and were successful in securing over 68 million dollars for RapidLynx to proceed.
- This was done in concert with the Broadband Working group, who subsequently become the Rapid Lynx Board of Directors include:

 Corporation, which consists of members: Mark
 Bell (Aroland), Delia Okeese (Marten Falls) and
 Bill Spade (Eabametoong)

Education

- Engagement with all levels of government to support the educational needs of Matawa First Nations students
- Partnerships with the City of Thunder Bay to help create Matawa Student Accommodation Centre and a Youth Safe Sobering Site



- Securing of mental health services for students at the Matawa Learning Centre
- The Matawa Chiefs have taken an active role in supporting the educational needs of the Matawa First Nations members over the last year
- Following the inspection and recommendations of Aroland Chief Dorothy Towedo and Neskantaga Chief Wayne Moonias, the Matawa First Nations Chiefs supported the further development of the Matawa Learning Centre at the former Grandview Lodge sight in Thunder Bay
- On December 13, 2017, the Matawa First Nations
 Chiefs met with the Matawa Regional Education
 Committee (now the Matawa First Nations
 Education Authority*), Matawa Education staff,
 and designers to go over the capital and operating
 plans for the Matawa Learning Centre. This
 discussion was centred on making the lives of
 students better through wrap around supports
 and creating a holisitic education environment.
 Congratulatory remarks and support to the
 Matawa Educational Vision by Chief Peter Collins,
 Nishnawbe-Aski Nation Chief Alvin Fiddler and
 former Ontario Regional Chief Isadore Day
- Additional discussions and involvement of the Chiefs occurred for those who were able to attend the Matawa Education Conference in March 2018 and at graduations for students in Matawa related programs. Regular updates on new changes to Federal Educational Initiatives were also discussed at the Matawa First Nations Chiefs meetings
- The Chiefs have also supported Matawa Education Staff as an active participant in the Coroner's Inquest into Student Deaths in Thunder Bay including supporting the Matawa Learning Centre's application for a Safe Sobering Site

- Finally, the Chiefs have worked with KKETS staff to promote community training supports in the areas of adult education, apprenticeships, worker associations and need for worker retention

CHALLENGES:

Consistent Funding

- There is a need for enough funding to arrive at the right time so communities and Matawa can start initiatives early in the fiscal year
- Funding needs to be long term, not project based or initiatives will falter and staff will be lost

Communications

- Many issues being asked of communities by government are quite complex – translation and interpretation of material and ideas are required
- Capacity building and understanding of project management of these issues is major asset required
- On-going communications to community members of what is happening or not in negotiations and how much information should be confidential
- Communications within and between communities at all stages of initiatives

Multiple Ministries and Departments

 Co-ordinating between the different Ministries and Departments to achieve a whole of government (or one-window) approach is difficult but necessary.

Time Pressures

- Governments want communities to make fast decisions however, communities need time, capacity building and resources to assess their traditional territory, service needs, and future plans.
- Elections at the First Nations and Ontario level can create timing challenges.

OPPORTUNITIES:

- Greater First Nation jurisdiction of First Nation traditional territories
- Bringing in the federal government into negotiations
- Increased health and social supports to First Nation members
- Increased housing to First Nations
- Increased financial capacity building for First Nations
- Increased infrastructure and communications to First Nations
- Creation of economic structures to support First Nations owned and operated by communities that build collective momentum and First Nation accomplishments

OVERVIEW OF MATAWA CHIEFS COUNCIL MEETINGS:

This past year, the Matawa Chiefs in Assembly passed 42 Resolutions. In comparison, they passed 55 last year. In addition to the 2017 Annual General Meeting (AGM) held in Ginoogaming First Nation, they held 5+ meetings throughout the year (they held 7+ last year). 

UPDATE:

The proposal was approved for \$989,000 through Jordan's Principle Choose Life. Due to the increase of staff and the delay in the flow of funding it was difficult to begin the partnership during the first semester. The partnership with St. Joe's was underway in the second semester and will continue in the fall of 2018.

UPDATE:

Ongoing updates have been provided to the Matawa Chiefs as well as the Matawa First Nation Education Authority. Community presentations have also been conducted. While the Matawa Education department has been aggressive in pursuing funding for positions to implement community-based recommendations. the Federal and Provincial governments have yet to provide the necessary funding. The annual report to the coroner has been submitted June 2018.

THEREFORE BE IT RESOLVED the Matawa Chiefs in Assembly approve the feasibility study and related business and operational plans which have been developed for the centre, and support the creation of a Matawa First Nation student education and care centre; and

FINALLY BE IT RESOLVED that the Matawa Education Department continue to work with the City of Thunder Bay and the governments of Canada and Ontario to secure adequate funding for the construction, operations and programming associated with the education and care centre.

UPDATE:

Officially, the City of Thunder Bay granted Matawa First Nations Management the former Grandview site on Lillie St, in January 2018. Phase One of the renovations began in February 2018 and completed in April 2018. Business Plan/Feasibility study was completed in May 2018. Phase Two will be completed by August 2018 this will allow for the MLC to be operational for the 2018/19 school year.

THEREFORE BE IT RESOLVED that the Matawa Chiefs in Assembly direct the Matawa Education Department, in collaboration with the Regional Advisory Committee on Education and the Chiefs' Spokesperson for Education, to work with the Ontario Ministry of Education and Indigenous and Northern Affairs Canada to develop a student-centred funding model and policy which will allow funding for Matawa secondary students to support their attendance at the school of their choice, regardless of their place of residence, up to and including the age of 21, and which will follow students who move between schools during the school year; and

FURTHER BE IT RESOLVED that Matawa Chiefs in Assembly direct the Matawa Education Department to access resources from the Ontario Ministry of Education and Indigenous and Northern Affairs Canada to develop a workplan and related timeline to carry out this work; and

FINALLY BE IT RESOLVED that Matawa Chiefs in Assembly direct the Matawa Education Department to provide updates to the Chiefs and to the Regional Advisory Committee on Education on a regular basis, and a report to the Matawa Chiefs in Assembly at the 2018 AGM.

UPDATE:

In collaboration with the Matawa First Nations Education Authority, and the Matawa Chiefs Spokesperson on Education we met regularly with Indigenous and Northern Affairs Canada and Ministry of Education to develop a student-centred funding model and policy. The federal and provincial governments continue to state this is their primary goal but have not approved a formalized process for this to happen. This work will continue into the next school year. To date, capacity building programs such as renewable energy workshops, business support workshops, economic development conference and schools solar/wind demonstration project have been developed. In the near future, we will be providing a procurement training on how to fill our applications to different agencies but will continue to look for additional funding.

THEREFORE BE IT RESOLVED that the RFWG be authorized to begin working on drafting the terms of reference documents for joint working groups for Environment, Socio-Economic (including Community Benefit Fund), Infrastructure and Revenue Sharing;

FURTHER BE IT RESOLVED that a key purpose of the joint working group is to coordinate discussions with the province to enhance the community engagement process in order to provide the communities with more up to date information and improve their ability to make informed decisions; and

FURTHER BE IT RESOLVED that these discussions are not to be construed as negotiations, but rather as an effort to gather information to assess the possibilities of more in-depth negotiations once the community drive process has been more fully engaged. It is understood that there will be ongoing regular updates provided to the Chiefs and communities; and

FINALLY BE IT RESOLVED that the draft terms of reference for the Regional Framework Joint Working Groups will be provided to the Chiefs for approval and further direction throughout the process.

UPDATE:

Since the formation of the Regional Framework Working Group (RFWG), this group has been meeting regularly and presenting recommendations for consideration to the Chiefs and community members.

Once the RFWG received direction (in this resolution) to begin to work with the province on Joint Working Groups, there have been several meetings to develop the draft Terms of Reference (ToR) for the RFA pillars (Environment, Socio-Economic (including Community Benefit Fund), Infrastructure and Revenue Sharing), as well as an over-arching ToR for the main Joint Work Group known as the RFJWG (Regional Framework Joint Work Group). The draft ToRs were presented the Chiefs for consideration but are still in draft form.

The RFJWG has also met to coordinate discussions with the province where multiple ministries were invited, focusing initial discussions/information-sharing on the environmental and socio-economic pillars. The Matawa RF Department has provided ongoing regular updates of the RFWG and RFJWG meetings to both the RFWG members and the Chiefs, to be distributed to community members and others as determined by the Chiefs. The RFWG and RFJWG meetings provided opportunities to draft materials, potential strategies, draft documents and draft ToRs for the Chiefs' consideration, and to gather information on the RFA pillars to further community discussions.

THEREFORE BE IT RESOLVED that the Matawa Chiefs Council direct the Matawa Jurisdiction Working Group (JWG 4 Matawa Representatives) to proceed with returning the draft Statement of Shared Commitments (January 24, 2018 draft) to the Ontario representatives of the Joint Jurisdiction Working Group (JJWG) for the consideration of a response by Ontario.

FURTHER BE IT RESOLVED that the Matawa Chiefs Council direct the MJWG to proceed to the next round of discussions with the JJWG to present, discuss and receive Ontario's response to Matawa's proposed revisions and additions to the draft Statement of Shared Commitments; and

FURTHER BE IT RESOLVED that the Matawa Jurisdiction Working Group (MJWG) will prepare a report to the Matawa Chiefs Council on the outcomes of the Matawa/Ontario JJWG discussions and Ontario's response once completed, for the consideration and direction of the Matawa First Nations; and

FURTHER BE IT RESOLVED that community engagement and presentations continue so as to share information with community members and gather additional input; and

FURTHER BE IT RESOLVED that the JWG continue to participate in community engagement as requested by each individual First Nation; and

FINALLY BE IT RESOLVED that the JWG ensure that each First Nation representative receive the support required to keep their community fully informed including the option of bringing a community member as an observer into the meeting(s) with the Deputy Ministers.

UPDATE:

As directed in the resolution, the JWG (4 members) proceeded to the next Matawa/Ontario Joint Jurisdiction Working Group (JJWG) meeting held on January 30, 2018. At that time, the January 24 2018 draft Statement of Commitments was presented to Ontario for consideration and response. On February 8, 2018 Matawa legal counsel met with Ontario legal counsel to review the proposed changes and revisions, answer questions and report back to the JWG.

On March 19, 2018 the next and most recent JJWG meeting was held. The Ontario representatives presented their response in the form of the March 19, 2018 draft Statement of Commitments. A briefing email and the Ontario March 19, 2018 draft SOC were distributed immediately at the end of day to the Matawa Chiefs Council and all 9 members of the MJWG.

Options were prepared by the MJWG and legal counsel for a Matawa response to Ontario's March 19, 2018 draft SOC, and the options were presented to the Matawa Chiefs Council at their meeting in Marten Falls First Nation on April 4, 2018. Work has continued on the Ontario response, including a letter to Premier Kathleen Wynne on April 24, 2018 requesting a meeting with the Premier and a response to the Matawa draft SOC of January 24, 2018.

In terms of community engagement, the MJWG continues to work to support communities and the Matawa Chiefs Council. In addition, as specifically directed to provide the option of community member observers in the JJWG meetings – this directive has also been followed for the January 30, March 19 meetings and will continue to be followed for future meetings.

Each community will receive 50% of last years budget in two quarters: Q1 45% – Q2 45% - with 10% holdback.

 to key buildings, greenhouse that will be installed at our schools, solar farm / storage system and refurbishment of
 existing generators that will be used as a backup system
- Installed in all Matawa communities, the aim will be to build capacity and train our people for future generation

THEREFORE BE IT RESOLVED that the Matawa Chiefs direct the Matawa Economic Development to work with the Matawa Economic Development Committee to explore this potential project including implications on neighbouring First Nations.

FURTHER BE IT RESOLVED that the results of this fact finding be brought back to the Chiefs for review before any advancement of the initiative.

UPDATE:

Fact finding has included the development of a draft MOU, a preliminary environmental review by Hatch (with no fatal flaws identified) and, a plan to set up future meeting with neighbouring First Nations to provide them with updates on the potential project and to look at different possible impacts and partnerships that may be involved.

The project continues to have potential to be Ontario's largest energy storage facility with potential to produce 600Mw. The Pumped Storage Hydropower Reservoir would be located on the north shore of Lake Superior utilizing approximately 200 acres of land on the plateau on the north shore of Lake Superior within the Traditional Matawa Territory.

Other benefits continue to include: it being in alignment with growing system operational needs of Northwestern Ontario, is located within a 2km connection point of the critical 230kv east west transmission tie; and has a secured project site land purchase/lease option with site ownership from the Municipality of Schreiber. It also continues to be a strategic fit with provincial renewal energy and related infrastructure investment mandates.
